D. Additional requirements

This Inter-institutional agreement envisages further invigoration of cooperation in the field of high and higher education including professor and student exchange programmes, international projects, horticulture, agriculture and environment research, documents and information exchange about high and higher school educational systems and programmes, active participation at the international academic conferences, the organization of informal education, expert excursions, the use of the information and communication technologies and other activities contributing to higher quality level and know-how in the field of horticulture, agriculture and environment.

On the basis of this Inter-institutional agreement the two institutions, i.e. the Biotechnical Centre Naklo, Slovenia, and the Polytechnic of Rijeka, Agricultural Department in Poreč, Croatia are going to establish a joint committee functioning as an advisory organ for cooperation in the field of high and higher education.

The forms of international cooperation:

- scholar exchanges based on projects related to curriculum or the development plans of the schools
- the organization of international academic conferences and other international events
- the organization of national or international events
- participation of the student groups at the international festivals or other international events prepared after the preliminary project work
- projects supporting language and culture variety at schools
- academic research in the field of horticulture, agriculture and environment
- writing and publishing of expert and scientific articles contributing to the development of knowhow in the field of horticulture and agriculture
- other international expert projects

The cooperation for the development of the two centres will include the exchange of the knowledge, experiences and opinions of the experts from different areas like agriculture, horticulture, viniculture, fruit growing, the economics and other fields, representing challenges for both partners and improving their quality and knowledge.

- 2. The receiving institution will send its decision within 4 weeks.
- 3. A Transcript of Records will be issued by the receiving institution no later than 4 weeks after the assessment period has finished at the receiving HEI.
- 4. Termination of the agreement

[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]

F. Information

1. Grading systems of the institutions
