# Forrest: Slovenia's major natural asset (one out of several!)

Forest cover: > 60 % of Slovenia

Increment of wood: 7,5 million m<sup>3</sup> PA

Only 1/3 felled (3 million m<sup>3</sup>)

Considerable share: exported as raw timber

Sorry state of wood processing industry ?! (lost jobs, revenues, added value)

- Regional impact, good practices






# Green budget reform package and benefitting sectors




#### Revenue-neutral tax shift

(temporary: additional revenues instead of austerity cuts)


